ASPIRE educators receive instructional support from a designated coach while delivering high-quality, state-funded PreK to children who may fall into a variety of at-risk categories. Our session will include interactive discussions, hands-on activities, and real-life scenarios from educators who have children who may be experiencing unsettled housing, come from multilingual homes, fall within 300% of the poverty line, or have an IEPs/IFSP. 
